Mónica Ferrín is Intalent and Ramón y Cajal researcher at the Faculty of Sociology, University of A Coruña. Before moving to A Coruña, she worked at Collegio Carlo Alberto in Turin, and at the University of Zürich. Her research focuses on citizens' democratic attitudes and gender inequality in public involvement. She is the sponsor of the European Social Survey Round 10 module on 'Europeans' understandings and evaluations of democracy'. She is also interested in understanding the gender gap in public participation. Her research has appeared in the European Journal of Political Research, West European Politics, or the International Journal of Press/Politics.

Enrique Hernández is an associate professor at the Department of Political Science at the Universitat Autònoma de Barcelona. He completed a PhD in Political and Social Sciences at the European University Institute in 2016. Enrique's main research interests are in political attitudes, public opinion, electoral behavior, and democracy.

Hanspeter Kriesi is a part-time professor for Comparative Politics at the European University Institute in Florence. Previously, he held the Stein-Rokkan Chair at this university and he has been teaching at the universities of Amsterdam, Geneva and Zurich. His wide ranging research interests include the study of various aspects of democracy, political communication, political mobilization and opinion formation. 2017 he has received the Mattei-Dogan Prize, 2022 honorary doctorates from the University of Lucerne and the Mid-Sweden University in Sundsvall. Together with colleagues from the LSE and the University of Milano he is currently working on an ERC Synergy project on the impact of the recent multiple crises on the resilience of the European Union.

Pedro C. Magalhães is a Senior Research Fellow at the Institute of Social Sciences of the University of Lisbon, Portugal. He specializes in comparative public opinion, elections, and judicial politics, with a particular focus on the study of democratic attitudes and institutional legitimacy. Previous work has been published in the *American Journal of Political Science*, *Political Psychology*, and *Comparative Political Studies*, among others.

Radoslaw Markowski, professor of political science, at the Center for the Study of Democracy (Director), University of Social Sciences and Humanities, Warsaw and PI of the Polish National Election Study. Recurring Visiting Professor at CEU, Budapest, in the past visiting professor at Duke, Wisconsin-Madison, Rutgers universities. He has published in peer reviewed journals, among other in *Electoral Studies, Party Politics, Political Studies, West European Politics*, and has edited or co-authored many books in Cambridge, Oxford, Mancherster University Press, Sage and Routledge. An expert of the Varieties of Democracy (V-Dem), Bertelsmann SGI project and the Hertie School of Governance. Member of the editorial advisory boards of a number of academic journals, among them: *European Journal of Political Research*, *Political Studies*, *Populism, European Union Politics*,

Sergio Martini (PhD in Political and Social Sciences, Universitat Pomepu Fabra) is Post-doctoral Fellow at the Department of Social, Political and Cognitive Sciences of the University of Siena. His research interests include public opinion, voting behavior, democracy and methodology. His articles have appeared among others in the European Journal of Political Research, Political Psychology and West European Politics. His book co-authored with Mario Quaranta and entitled "Citizens and democracy in Europe: Contexts, changes and political support" is published by Palgrave (2020).

Irene Palacios is an Assistant Professor at the University of Murcia (Spain) and a Research Associate at the Cambridge Centre for the Future of Democracy. She holds a PhD in Political and Social Sciences from the European University Institute in Florence and has been a Postdoctoral researcher at Maastricht University. She is the author of two books on citizens' attitudes about the quality of democracy in Spain and several journal articles. Her main research interests are located in the field of democratic attitudes, quality of democracy and political institutions from a comparative perspective.

Pedro Riera joined the Department of Social Sciences of the University Carlos III of Madrid in 2015, after having served as lecturer at the School of Government and Public Policy of the University of Strathclyde (Glasgow, UK) between 2013 and 2015. He obtained tenure in 2017 and became associate professor (i.e., profesor titular) of political science in 2019. His main areas of interest are comparative voting behaviour and electoral systems with a quantitative approach. His research has been published at the European Journal of Political Research, Comparative Political Studies, West European Politics, Political Behavior, and Party Politics, among others

Dietlind Stolle is James McGill Professor in Political Science at McGill University and former Director of the Inter-University Centre for the Study of Democratic Citizenship. She has also been elected Fellow of the Royal Society of Canada. Stolle conducts research and has published on voluntary associations, trust, social capital, ethnic diversity, immigrant integration, political participation, neuro-politics, democratic backsliding and gender and politics. Her work has appeared in APSR, JOP, PNAS, BJPS and other journals. Her book "Political Consumerism—Global Responsibility in Action" (2013) by Cambridge University Press (with Michele Micheletti) won the Comparative Politics Prize of the Canadian Political Science Association. In 2021/22 she was a Fernand Braudel Fellow at EUI, while in 2023 she joins the Robert Schuman Centre at EUI as a visiting fellow working on the EUI-yougov survey on European solidarity.

Mariano Torcal: is a full Professor in Political Science and ICREA Research Fellow (2014-2019, and 2020-2025) at the Department of Political and Social Science at the Pompeu Fabra University in Barcelona and Director of the Research and Expertise Centre for Survey Methodology (RECSM). Ex-President of WAPOR Latinoamérica University. Senior Adjunct Faculty at the Graduate School of International Studies at the University of Denver since 2006. He has published articles several articles on topics such as political disaffection, political trust and satisfaction with democracy, electoral behavior, political participation and party system institutionalization in major international journals. Member of The Editorial Boards of many International Journals. Current co-editor of Revista Latinoamericana de Opinión Pública.

Bernhard Weßels is a professor of political science at the Humboldt University Berlin, and he was the acting director of the research unit "Democracy and Democratization" at the WZB until its closure in 2022. He was the principal investigator of the German CSES election study since 1996 and has co-directed the German National Election Study from 2009 to 2020. He is directing the DFG-financed manifesto project and Work Package 4 of the EU-funded OPTED project. His research interest includes comparative political behavior, interest intermediation, and political representation.
